### **KASHIA BAND OF POMO INDIANS ARP Housing Assistance Application**

**Tribal Members:** With the help of the American Rescue Plan, the Kashia Band of Pomo Indians of Stewarts Point Rancheria is offering housing assistance through multiple programs. If tribal members have suffered a job loss or other substantial loss of income due to the COVID-19 pandemic and are unable to pay rent or mortgage the tribe is offering assistance through the housing programs listed below. Please select the program relevant to your needs.

- Emergency Rental Assistance Program** – The Tribe may be able to assist you with 2-3 months of emergency rental assistance. You must be income-qualified and show proof of financial hardship caused by the pandemic. The income requirements will vary depending on which county the qualified applicant resides.
- Emergency Mortgage Assistance Program** – The Tribe may be able to assist you with 2-3 months of emergency mortgage assistance. You must be income-qualified and show proof of financial hardship caused by the pandemic. The income requirements will vary depending on which county the qualified applicant resides.
- Emergency Rental/Mortgage Assistance Program** – The Tribe may be able to assist those that are unable to income qualify for the HUD-funded rental/mortgage assistance programs with 1-2 months of rental or mortgage assistance.
- Chronically Homeless Emergency Housing** - The Tribe can shelter just the applicant in a hotel until they are able to secure more permanent housing.
