

November 14th, 2023 Tribal Historical Preservation Officer, Anthony Macias attended the Gleason Beach Ribbon cutting ceremony along with Kashia Elder Robert Smith.

Gleason Beach lies along the Sonoma coastline, midway between the community of Bodega Bay and the Russian River, where State Route or Highway 1 travels along the bluffs overlooking the Pacific Ocean. Coastal erosion resulting from factors such as wave action, sea level rise, surface water runoff from surrounding land uses, and groundwater intrusion have contributed to rapid bluff erosion over the last few decades.




Caltrans is realigning a half-mile stretch of Highway 1 up to 400 feet east of the current alignment. The current highway will be repurposed to become a portion of the California Coastal Trail, and parking spaces will be provided to maintain and improve public access to the beach. Additionally, the existing culvert over Scotty Creek will be removed. The culvert currently poses a barrier to the migration of state and federally listed anadromous salmon and steelhead. Scotty Creek will be daylighted at the mouth of the creek and restoration efforts will be conducted to improve the riparian habitat along Scotty Creek. The Gleason Beach Project will contribute to maintaining a safe and resilient Highway 1 for future generations.

From November 2nd to the 4th, KDEP conducted a CRV recycling, tire recycling and an electronic waste (E-waste) collection event. We were able to recover: approximately 794 lbs. of cans & bottles, a total of 28 tires, and a few e-waste items! January Is Mental Wellness Month

The high rates of alcohol, substance use and mental health disorders, suicide, violence, and behavior-related morbidity and mortality in American Indian and Alaska Native communities continue to be disproportionately higher than the rest of the U.S. population. Studies show Indigenous people have disproportionately higher rates of mental health problems such as suicide, post-traumatic stress disorder, violence and substance use disorders. These high rates result in American Indian and Alaska Native people reporting serious psychological distress, 2.5 times more than the general population over a month's time. Below are key statistics defining the health disparities experienced by the American Indian and Alaska Native population.

<u>Highest rates of suicide</u> of any minority group within the U.S. and rates are increasing since 2003, as well as <u>high rates of</u> <u>substance use disorder</u> of both illicit drugs and alcohol use

From 2016 to 2020, they experienced alcohol-related deaths at significantly higher rates (51.9/100,000) than the rest of the U.S. population (11.7/100,000) $\frac{1}{2}$

Highest prevalence of methamphetamine use, as well as methamphetamine use disorder, methamphetamine injection, and with significant increases in methamphetamine overdose $\frac{2}{3}$ In 2019 and 2020, <u>drug overdose</u> <u>death</u> rates were highest for non-Hispanic American Indian and Alaska Native people at 30.5 and 42.5 per 100,000, respectively

From 2019-2020, the American Indian and Alaska Native <u>overdose death</u> <u>rates</u> increased by 39%.

Despite the strengths of American Indian and Alaska Native (AI/AN) families and communities, suicide remains a devastating and all too frequent event. Complex, interrelated factors contribute to an increased suicide risk among AI/AN people and include mental health disorders, substance abuse, intergenerational trauma, and community-wide issues. Factors that protect AI/AN youth and young adults against suicidal behavior are a sense of belonging to one's culture, a strong tribal/spiritual bond, the opportunity to discuss problems with family or friends, feeling connected to family, and positive emotional health.

Cooperation among Tribal, Federal, and other partners is imperative to create a safety net of interconnected programming - health, education, law enforcement, public health and well-being, economic development, and physical and behavioral health - to maximize effectiveness of services and to protect individuals against suicide risk.
